2024-25 Edition Health Plan Report Card Summary of Changes

This document summarizes key changes to the upcoming 2024-25 Edition Health Care Quality Report Cards, which include data from Measurement Year (MY) 2023.

Health Plan Report Card – 2024-25 Edition Updates

Below are the updates to the Health Plan Report Card HEDIS¹ measures for MY 2023:

- FVA (*Flu Shots for Adults*) was retired for HEDIS MY 2023. As such, FVA has been removed from the CDII measure set and MSC² (*Doctor Advises Patient to Quit Smoking*), the remaining measure under the *Treating Adults* topic, has been moved to a new topic, *Appropriate Use of Tests, Treatments and Procedures*.
- The *Treating Adults* topic has been retired.
- BCS (*Breast Cancer Screening*) was retired for HEDIS MY 2023 and replaced with BCS-E, an Electronic Clinical Data Systems (ECDS) measure.

CDII did not incorporate any changes related to the CAHPS³ measures.

MY 2023 CDII HEDIS Measures and Topics

The Category “Quality of Medical Care” aggregated all-HEDIS summary performance score, composed of thirty-three (33) commercial HEDIS measures. Eight (8) condition topics fall under this category, while two measures are display only⁴:
