The Vision for Data Exchange in California


Once implemented across California, the Data Exchange Framework (DxF) will create new connections and efficiencies between health and social services providers, improving whole-person care.


The DxF is California's first-ever statewide Data Sharing Agreement (DSA) that requires the secure and appropriate exchange of health and human services information to enable providers to work together and improve an individual's health and wellbeing.

Scope, Composition, & Cadence



Scope

• The purpose of the Social Data Exchange TASC focus group is to advise CDII on a reference model for social data exchange.



Composition

 Subject matter experts with technical and operational experience in data exchange representing health and service providers, intermediaries, vendors, and state/county government



Meeting Cadence

- CDII anticipates four, one-hour meetings held every other week
- For continuity, members are asked to prioritize attendance at all meetings if possible



Background

Goals and Purpose

- The DxF is responsible for enabling exchange of health and social data to support whole person care initiatives in California.
- A quick landscape survey by CDII at the end of 2024 identified limited instances of active health and social data sharing, however more are emerging.
- CDII identified the need for a reference architecture to inform DxF and participants.
 - The reference architecture is not a roadmap, but a vision of what a successful ecosystem should include.

Methodology

Approach:

- Identified notable examples at the <u>county level</u>, where health and human services data is being shared across agencies, health care organizations, and community-based organizations.
- Scope was limited to projects in production successfully sharing health and social data at the local/county level.
- Captured five examples encompassing three different models:
 - 1. county driven;
 - 2. health system driven; and
 - 3. Community Information Exchange (CIE) or Social Health Information Exchange (SHIE).

Output:

- The reference architecture represents the commonality across the different county models.
- The goal is to launch a learning systems approach to creating a social data sharing ecosystem in communities across California.


